



Simply, easily and quickly explained.

The S-PAY Network Marketing Plan is a simple step-by-step plan with compression where you can receive referral commissions over 7 levels. The plan is divided into 6 bonus levels, for which certain criteria must be met.

Getting started

After registering free of charge on the website - ico.s-pay.me - you are automatically in the "1 star INACTIVE"



bonus level. (You can see this in your account by a gray star in the upper right corner of the page.) You can now start recommending S-PAY. Every new participant who registers through your advertising link on the ico.s-pay.me page is automatically assigned to you and is placed

in your downline, directly below you. If the new participant buys S-PAY tokens, you as his sponsor will receive 20% of the order value in euros as a referral bonus in your bonus wallet - and that for every future order too! You can enter as many direct partners as you like, there is no limit!

So far, our plan is a traditional recommendation system. If you remain inactive and participants you have referred recruit new participants, you will not receive anything! Commissions from your downline are forwarded to the next active participant on your upline (compression). In order not to lose any commission, you should activate yourself. You can do this very easily by purchasing at least 1000 tokens for 60 euros. With the purchase you are automatically classified in the bonus level 1 star ACTIVE.

1 star bonus ACTIVE (a yellow star is displayed in the account)



In this bonus level, in addition to your direct commission, you will receive 5% from each of the next 2 levels of your downline.

Example: You advertise A and B advertises C. For A you receive 20% of the order value with every order. For every order from \underline{B} you receive 5%, for orders from C also 5%.

<u>So</u> if a participant / investor on the first level of your downline purchases tokens for EUR 6,000.00, you will receive EUR 1,200.00 commission. If a participant purchases tokens on your 2nd and 3rd level for

the same amount, you will receive EUR 300.00. Now imagine that you have brought two or three people into the system who are very active and are starting to build a large downline. Then things get really interesting.

As soon as you and your downline achieve a quarterly total turnover of EUR 7,500.00, you will be assigned to the **2-star ACTIVE** bonus level for the next billing. This means you get an extra layer. Instead of three levels, you will then also receive commissions from the 4th level.

In order to achieve bonus levels, the following downline sales are required within 90 days:

Bonus Level	1/4 Year Sales
	Greater = 0,00 Euro
**	Greater 7.500,00 Euro
	Greater 25.000,00 Euro
	Greater 75.000,00 Euro
	Greater 250.000,00 Euro

Once reached, bonus levels are retained permanently, i.e. there are **no downgrades** with S-PAY. Downline commissions are only available if you are active at the time of billing. Upgrades are always made after billing. For example, if you exceed a sales limit on the 15th of a month, you will only be upgraded after the next billing! Invoices are always made on the 1st working day of each month.


What does it mean to be active?

In order to receive downline commissions, you must be active yourself at the time of billing! This means that you have to place an order of at least 1000 tokens / 60.00 euros yourself during the billing period. **As soon as your order is confirmed (paid), you are active for 1 month.** In the back office or partner area, your bonus level is indicated by yellow stars. The number in brackets - next to the stars - shows you how many days you are still active.

After the displayed days have expired, you will be inactive and the stars will be displayed in gray. If you have not set up a subscription or the balance of your commission wallet is not sufficient for the next automatic order, the system will show you (from 14 days before you become inactive) a red warning in the partner area, which tells you how many downline commissions you may lose if your bonus account remains inactive. If you regularly receive higher downline commissions, we recommend that you set up an automatic order in the partner area and make sure that your commission wallet has sufficient coverage for the order. The wallet can be topped up by bank transfer, standing order or with crypto currencies if the balance is not sufficient.

You always receive commissions from your directly referred partners!
